TGE : Transnational Giving Europe

Cross-border donations in Europe



Transnational Giving Europe (TGE) is a partnership of leading European foundations and associations facilitating tax-efficient cross-border giving within Europe. The TGE network enables individual donors resident in one of the participating countries to financially support the ADOR and to support the Royal Opera, while benefiting directly from the tax advantages provided for in the legislation of their country of residence.

Advantages for the donor

- You have access to the same privileges as our donors residing in France.
- You benefit from the tax reduction granted by your country of residence. Cross-border donations are made under the best tax conditions.
- A simplified, standardized and secure procedure.

How to donate to ADOR from Europe ?

1. The donor contacts the ADOR's office which will help lead you to make your gift
2. The donor contacts the partner foundation in the country of his/her residence
3. The donor makes the gift to his/her home-country foundation

A 5% contribution is taken on the donated amount for gifts up to 100,000€. For higher gifts: 1% of the amount in excess of the 100,000€ is donated to TGE. The maximum contribution is 15,000€. Banking fees are invoiced when actually incurred.
